PLANNING COMMISSION – There was report at this time.

ASSESSOR – Assessor reported read by Supervisor Lech: 3 sales, 10 inquiries. March attended Annual IPAI Conference for continued education & requirements met, completed some site visits from letters that were sent, will be out on medical leave but office can be reached by phone & email. Reminder Ag exempt means permit fees are waived, it does not mean Tax Exempt attended a couple Farm Committee meetings with other Assessors to prepare for the next Quad and get clearer guidelines. Official books have been picked up and working on them, exemption forms are available for renewal. HIGHWAY COMMISSIONER – Commissioner Nickels reported picking up garbage, patching, brush, signs, equipment, ATM sign, met with Jeff for the truck loan, pulled posted signs early all except Hillside Rd, Greenwood Township came to help with brush & trees, 4/21/25 Vander Karr Rd Bridge will be closed for about 4-6 weeks, there is free community mulch while supplies last, CBGD grant presentation may get \$550K for Green Street repairs & working on this years budget.

SUPERVISOR: CEMETERY – 0 staking, 0 grave sales, \$200 donation. GENERAL ASSISTANCE – 0 GA & 1 inquiry/application picked up but never returned. SUPERVISOR – Traveled to Springfield for Township Consolidation seminar, meet with residents that are interested in the open Trustee position at the new term, Annual Town Meeting preparation, met with bank for loan paperwork for Highway Department, completed fiscal year end.

CLERK – One remains yet to file Statement of Economic Interests for current boards.
