PLANNING COMMISSION – No planning commission report at this time.

ASSESSOR – Assessor Combs reported 4 sales - low, 6 correspondence – low with the average 2-3 per week. Would like to get a second license for the program so more than one person can work on the computer at once. Books may be ready for county next week expect to be published end of November which will be difficult for the Levy to posted & completed by deadline.

HIGHWAY COMMISSIONER – Commissioner Nickels reported boom mowing with Alden's mower for 3-4 weeks in exchange for 1 week of work for them. Also brush, trash, working on equipment, mowing, paved with Greenwood, patching, found plow driver, Railroad crossing on Seaman has been pushed back to next year, helped with a closure of IL Rte 47 for IDOT & the Village of Hebron.

TRUSTEES – No report given.

SUPERVISOR: CEMETERY – 4 staking, 0 grave sales. There is a family that would like to donate 13 graves back to us. Wreathes Across America will not be able to help with volunteers and the program. Sexton Tom Evers would like to resign. GA – 1 emergency assistance approved. SUPERVISOR – Flag pole is fixed. Kurt & Zeke fixed the light in the hallway. 1 FOIA for GA information. The County will no longer be providing their worksheet with levy figures, info will be located on their website, Levy needs to be posted 20 days before approval. SB3789 Local Government Consolidation Committee needed 1 year from effective date 06/09/2022, to study township efficiencies consisting of the Board, 2

residents with a 3 meeting minimum. Reports to County 18 months after formation & dissolve until 10 years later. ADMINISTRATION – Trustee Von Bergen motion to accept the Audit FYE March 31, 2022. <u>NEW BUSINESS</u> — Trustee Von Bergen motion to accept Jim Vander Pal's formal presentation of the donation for the horse drawn road grader in the name of The Seaman Ancestors, if ever decide to not display it, the family would like it returned to the family and not scrapped.
