HIGHWAY COMMISSIONER – Routine work, flagger training, patching, budget is done, Nancy found a grant & submitted for Button Rd, want to sell oldest 5 yard w/plow, lawnmower & bucket truck maybe through WI Surplus. TRUSTEES – Nothing at this time.

CLERK – Computer not back, OMA site is up and running, take training & send clerk completed certificate. SEI is due by May 1st.

SUPERVISOR: CEMETERY – 1 staking, 0 grave sales. Too wet for cleanup. GA – 1 application taken, Assisted 1 disabled resident with Benefit Access Program(discount license plate sticker & Metra free ride pass), Dropped off weatherization application off for senior-waiting for them to contact for appointment. ADMINISTRATION – Due to receiving \$300k in grants, we have to file the full audit this year cost of \$3000 as opposed to \$1550 for just the financial statement prep. Worked with Highway Commissioner on Button Road grant through Lauren Underwood's office. Finished set up of Banyon accounting software, half of the employees have direct deposit set up. Would like to only give them one replacement for lost checks if not signed up. 1st Qtr of 2022 payroll reports are complete.

NEW BUSINESS – Set Budget Workshop date for Wednesday April 20th 6:30pm at the township offices, no action to be taken. Looked at grader measurements in comparison to where it may be place for sign & Eagle Scout Project.

OLD BUSINESS - There was no old business discussed at this time.
