Assessor – Assessor Combs reported: The McHenry County Assessor Association had a visual PAMSPRO training session on June 22nd at the McHenry Township: it was one on one training and wonderful. Nine townships were represented including staff, 2 County Assessment employees for a total of 19 people. It was a great training workshop. There is a Visual PAMSPRO Seminar on July 20th in Elgin, that I am attending. Inquiries: 12 emails, 5 phone calls and 4 office appointments. Site visits scheduled from 6 letters.
