<u>APPROVAL OF EXPENDITURES/BILL</u> – *Town Fund bills* – Trustee Werra made the motion to approve Town Funds expenditures in the amount of \$11,727.56. Second was Trustee Von Bergan. Roll call vote: Ayes 5, Trustee Werra, Trustee Mayerck, Trustee Von Bergen, Trustee Reed, and Supervisor Lech. Motion passed.

General Assistance Fund Bills – Trustee Mayerck made the motion to approve the General Assistance Fund expenditures in the amount of \$575.14. Second was Trustee Werra. Roll call vote: Ayes 5, Trustee Werra, Trustee Mayerck, Trustee Von Bergen, Trustee Reed, and Supervisor Lech. Motion passed.

Planning Commission – no report.

Assessor – Assessor Combs reported: IPAI class on preferential assessments June 29 – July 1. Attending for continuing education and to have the required number of credits hours needed. Alex Benitez, McHenry 6 appraiser made a link to a video of his presentation to the County Board about the tax equation that includes levy and assessments and put it into more understandable terms with an example for the public to understand. The link will be added to the assessors' page on the Township website soon. Assessor did some site visits and left hanging tags to contact the office. Working on County assessments before the books are turned in and going to site visits on 2021 permits that are computed for 2022. There are quite a few so Assessor and staff are doing their best to get to all of them. About 4 sales for June and none for July yet. Inquires phone/email for June - 13 and July - 12. Census posted outside of office.

Highway Commissioner – Commissioner Nickels reported that the Township has been patching roads, picking up trash, working on equipment. Shouldered work on Price Road with Greenwood Township. Finished 2nd mowing and cutting brush. Repaired two driveway culverts and did some cemetery work. Truck #7 to Rush Truck Center for repairs. Had to go out at night twice for flooding. Railroad tracks still

Supervisor - Cemetery - grave sales, zero stakings. Quarterly meeting will be held on 7/28/22.

Administration – Zeke and Kurt caulked all the windows on the outside of the building. Filled and fixed all holes along the outside of the building. Met with Colton regarding Eagle Scout project. New legislation – Public Act 102-1088 Township Government must by 6/10/23 and every 10 years after must form a committee to study local government efficiencies, an analysis of whether consolidation should be an option with another unit of government and create a report with recommendations on these items. Parking lot crack sealing was cancelled due to weather. Flagpole out front – we can not display the flag at half-staff, so we are not disrespectful when it comes to notices from the State.
